### ADDITIONAL QUESTIONS TO THE SUBJECT OF THE COMPETITION AND ORGANIZATIONAL ISSUES OF THE COMPETITION AND ANSWERS TO THESE QUESTIONS ON FEBRUARY 6th 2017

#### Question No. 1 from February 03, 2017

**Question:**

I would like to ask if I can participate in the competition without a company registration number from the Russian Federation? Income is taxed in the country of tax residency (Russian Federation).

**Answer:**

The contracting authority haven't restricted geographically the participation of contestants. The company from the Russian Federation could participate in the competition, provided that the professional competence is fulfilled as defined in paragraph 5.1 of the Competition.

#### Question No. 2 from February 03, 2017

**Question:**

Paragraph 5.1 Contestants point c) professional competence:

I wanted to ask if there are not, by chance, some alternatives for a team of architects from Russia - are not authorized architects of the relevant Member State of the European Economic Area or the Swiss Confederation.

**Answer:**

At least one of the authors of the proposal has to fulfill the professional competence as defined in paragraph 5. 1. The alternative is to invite the author of a person fulfilling professional competence as defined in paragraph 5.1 of the Competition.

#### Question No. 3 from February 03, 2017

**Question:**

Article 5.1 Contestants, point d) technical competence, demonstrated by:

— the submission of a list of at least 2 services whose subject-matter was performance of similar services, specifically the preparation of project documentation for the modification of public spaces, developed at least to the stage of studies, including the date these services were provided and the identification of the customer;

- Creation of project documentation of an art object. The project includes the design of the public space (before entering the metro station)
- Creation of project documentation of an art object. The project includes the design of the public space (in the public city park).

#### Answer:

Should it be a service in keeping with the Building Act: an architectural study of a public space. The contestant must be the processor (supplier or co-supplier), of such studies so that he could use them as a reference project. The supplier of the reference project has to be as well the author or co-author of the proposal handed in in this competition.

#### Question No. 4 from February 03, 2017

#### Question:

Article 5.1 Contestants, point d) technical competence, demonstrated by:

—the submission of a list of at least one set of project documentation of any completed construction, with a cost of at least CZK 10,000,000 net of VAT, including the date this documentation was completed and the identification of the customer.

I would like to ask if the fulfillment of qualifications should submit the following project:

- Creation of project documentation of a floor navigation system for metro for one of the largest cities.

#### Answer:

It is required to prove that the contestant provided realization of one project, whose price was at least 10 million CZK without VAT (by the Building Act - Implementation of a building permit and occupancy permit). The Contracting Authority requires the proof of this qualification to be sure that the contestant has experience with coordination of a realization like this.

#### Question No. 5 from February 03, 2017

#### Question:

PO1 Competition brief:

I would ask, what is the difference between "communication" and "information" area/panel/system?

#### Answer:

It means the same, communication = information area/panel/system. The aim of the panels is to inform the visitors or passing people about events held at the Prague Expo.
